#### Bidders Qualification Criteria for the above tenders shall be as follows:

- a. Bidder should be a manufacturer of brass fittings.
- b. Bidder should have supplied brass fittings to OIL & GAS / Petrochemical / Process Industries for GAS applications.
- c. The bidder should have executed Purchase Orders in any one of previous five years for supply of Brass Fittings to the industries as listed above as per any one of the following criteria:
  - i. Single purchase order, of at least **75,000 nos.**
  - ii. Two purchase orders, each of at least **40,000 nos.**
  - iii. Three purchase orders, each of at least **30,000 nos.**
- d. The Annual Turn Over of the bidder shall be at least **Rs. 3 Crores** in any one of the last five financial years.
